EXPLANATION:

Effective August 15, 2019, Dr. Susan Fritz is appointed Interim President of the University of Nebraska (special appointment) at an annual salary of \$540,000. Dr. Fritz will commence service as Interim President-Elect on June 1, 2019, serving as Interim President-elect through August 14, 2019, to facilitate the transition and transfer of duties to Dr. Fritz from President Hank M. Bounds.

Dr. Fritz's position as Chairman and Board member of the University Technology Development Corporation (UTDC) shall continue and the UTDC duties are included as part of the duties undertaken during the appointment as Interim President. Board of Director memberships currently held by Dr. Fritz, or previously approved by the Board of Regents, are hereby approved.

EXPLANATION:

Acceptance of this report will affirm the delegation of authority given pursuant to RP-6.3.1 for authorized University personnel to negotiate and enter into an agreement with AGB Search, LLC for presidential search consulting services.

Services and deliverables include:

- Facilitation of a pre-search study, which includes in-person meetings with representatives from the University of Nebraska Board of Regents, Search Advisory Committee, faculty, staff, students, alumni, and other constituents to ensure input into the needs of the University and understanding of desirable leadership attributes for the President.
- Development of a comprehensive leadership profile, which will include information about the position, the University, and the community.
- Cultivation and recruitment of a diverse candidate pool.
- Facilitation of reference checks and extensive background checks for due diligence.

The Association of Governing Boards of Universities and Colleges (AGB) is a nonprofit professional organization with over 1,300 member boards, established in 1921 to advance governance in higher education through research, services, and advocacy. AGB Search, LLC is a separate, but affiliated organization that provides executive search consulting services to institutions of higher education.

Lead consultants for this search are Dr. Rod McDavis, managing principal for AGB Search and former president of Ohio University; Dr. Sally Mason, executive search consultant and president emerita of the University of Iowa; and Dr. Garry Owens, executive search consultant and founding dean of the College of Visual and Performing Arts at Texas Tech University.
