Dear Chair Clare and Valued NU Regents,

First, I hope this note finds you all happy, healthy, and enjoying the early fall semester. I know many of you and have great respect for your leadership commitment to advancing higher education in my beloved, native State of Nebraska. As you may remember, I am a two-time graduate of both NU and UNO, and recently served as a Vice Chancellor for both UNO and UNMC. Currently, I am proud to say that I serve as the President of Pittsburg State University in Southeast Kansas.

Because of my significant and successful leadership experiences within the NU System and family roots in Nebraska I feel compelled to share my perspective with you regarding the current situation within the NU System. Obviously, it would be much easier to just ignore these struggles and simply focus on my work and life here in Kansas. Well, when you're raised by WWII parents, choosing to stay silent at a crucible moment isn't part of my DNA. I am writing to you because I care.

I'll just get to the point. I was driving my boys to their soccer matches in Kansas City this weekend and was doing my level best to listen to the NU/CU football game. I was more than surprised to hear President Ted Carter speak during the halftime show. I thought this was strange given his recent decision to leave Nebraska behind for Ohio State and more money/and perceived more prestige for him (I wasn't surprised). Then I started getting texts from many Nebraska friends and family. What the heck? Look, I'm sure this all has to do with finishing out his contract, but the optics are terrible. Good luck to him, he made his choice and now you are all left to pick up the pieces. At the very least, please pay him to stay away, and if he has any integrity left, he will pay back the University the remaining balance of his contract. Give it back to the students. It's time to be done with this chapter.

Moving on to the next chapter involves selecting a "next" President. I say next because stability in the position has clearly been a challenge. The ongoing instability adds to all sorts of problems on the individual campuses (i.e. enrollment declines, leadership mistakes, deferred decision-making, growing financial pressures, etc.). It is obvious to many that the past several Presidents have "used" Nebraska as a stepping stone to their future ambitions. Their priorities were clearly "me before we" focused. Quite honestly, this makes me sick. Why? It's personal to me. I love the University and care deeply about the State of Nebraska.

The final and most important point I want to make in this email is that the next NU System President is at UNMC, and his name is Jeff Gold. It is well known that the NU System currently has its hands full with major financial and leadership challenges. Before that, I was fortunate enough to serve for over three years as the Commander of US Strategic Command stationed at Offutt AFB, Nebraska, near Omaha. While there, my wife and I were lucky enough to get to know and become friends with Dr Jeff Gold. I now hear that Jeff is a candidate to replace Ted Carter as President of the University of Nebraska. You could not select a better leader. The purpose of this e-mail is simple — to provide my strongest endorsement for Dr Jeff Gold. I hope he is selected.



Dear Chairman Clare:

Please accept this unsolicited letter of support for Dr Jeffrey Gold to be considered for President of the University of Nebraska System. Given that Dr Gold is a very well-known internal candidate, I will not go into great detail describing his immense experiences leading academic institutions; managing complex budgets; charting highly strategic and visionary paths; inspiring a wide range of faculty, staff and students; raising significant amounts of external funding for the university; and advocating passionately for the totality of our great university system and state. All of this is well known. Instead, I will simply state my own experiences of Dr Gold in my role as an executive director of one of our three university-wide institutions and as a recently recruited faculty member.

In March 2023 and after 28 years at Yale (most recently as the Elizabeth Mears and House Jameson Professor of Child Psychiatry and Psychology and director of Yale's Edward Zigler Center in Child Development and Social Policy), I was humbled to be offered the position of executive director of the Buffett Early Childhood Institute at the University of Nebraska. Although it was a leap of faith to leave a 28-year relationship with a university where I'd imagined that I would one day retire, the immense opportunities to work across all four university campuses in the service of promoting better research, policy, and practice for young children were simply too great to pass. However, the actual decision to take that leap of faith was in very large measure due to my several conversations with Dr Gold. He offered a vision of the university system that was bold and strategic, focused on excellence and services to others. It is terrific to have a bold vision, but it is altogether different when that vision is combined with a clear strategy based on a deep knowledge of the system and the greater context around that system. It was these conversations with Dr Gold that allowed me to see the wisdom in a great leap of faith, and it is his continuing strategizing and movement that has caused me to be as deeply committed as I am to our great university and all it has to offer.

I meet with Dr Gold monthly in his role as provost of the university, and every three months I meet with him and the executive directors of the other two cross-university institutes — Daugherty Water for Food Global Institute and National Strategic Research Institute. These three cross-university institutes are unique to Nebraska, key differentiators in comparison to all other university systems. Dr Gold has been putting forward a highly strategic vision for leveraging these institutes to increase the

national competitiveness of our university system, as well as position us for greater service to the citizens of Nebraska and to our students.

Furthermore, the strategic plan he developed for the University of Nebraska Medical Center, where I hold my primary faculty appointment, is exceedingly well conceptualized and clear. I've seen him build upon this plan with faculty, regents, funders, and other stakeholders. He knows how to chart out clear directions that will move the university forward, and he knows how to build strong coalitions.

Very tough decisions will need to be made in charting the direction of our amazing and complex university system. As you know very well, these tough decisions need to be balanced by a deep understanding of how the university system is structured and how it fits within the greater context of Nebraska. We need a leader who will be here long enough to see this vision through, but a big part of that is having a leader who can hit the ground running immediately. In my humble opinion, we cannot afford a period of interim presidency to be followed by a new president learning the internal and external systems on a steep learning curve. Dr Gold is the most logical choice for moving us forward from the first day during this time of unprecedented challenge and opportunity. I am also positive that Dr Gold would be an exceedingly attractive candidate for university president at any top university, including the one I just left to come to Nebraska.

Barely more than one year ago, I had such immense faith in Dr Gold's vision and leadership that I decided to take a leap of faith greater than I would have imagined. And it is that same faith, coupled with all that I've witnessed in the past year, that has caused me to never doubt for a moment the decision I made or my commitment to all that is possible in our great university system. We are in an incredibly critical and delicate moment, and the correct leader will make all the difference in how this moment is navigated. We need one with bold vision, great courage, a deep understanding of the complex internal and external contexts, and the steady hand of a surgeon.

Thank you for the incredibly important work you and the rest of the committee are doing in deciding our next leader. The stakes could not be higher, and your thoughtful and measured leadership is greatly appreciated.
